Subject: Information about fire protection rules and fire alarms in Márton Áron Dormitory

Fire alarms are common in the dormitory, especially in the evening hours. Heat and smoke detectors installed in the building automatically trigger the alarm when smoke or hot air is detected.

In addition to the smoke spreading in the air, the fire alarms also go off when the concentration of dust increases. It is necessary to limit the use of deodorants, hairsprays and hair dryers to the bathroom. Regular cleaning with an open window is important in living rooms.

It is necessary to regularly check the cleanliness of the living rooms. A hair dryer thoroughly stirs up the dust in the room, and the fire alarm detects this at a given dust concentration and goes off.

I. RULES

§ 2 Rights and obligations of students

(7) Smoking, activities that cause fire and smoke are strictly prohibited in the dormitory buildings.

§ 6 Living rooms

(9) Taking into account the load capacity of the electrical network of the rooms and keeping in mind the fire protection aspects, cooking activities in the living rooms are prohibited. This is possible only in the kitchen rooms designed for this purpose.

§ 7 Provisions related to building operation

(6) In the case of a fire alarm, the person who caused the alarm must immediately inform the reception what caused the fire alarm to go off.

[The fire protection regulations of ELTE MÁSZ Dormitory](#) are in accordance with II. chapter 2.12. section provides for the student's fire protection responsibility and the fire protection rules. The IX. According to point i) of chapter ELTE initiates prosecution against the person who commits a fire protection irregularity (this also applies to possible disaster prevention fire prevention fines!).

II. IT IS FORBIDDEN

2.1. in the dormitory building

- smoking
- use of open flame and fire-causing activity

2.2. in the dorm rooms

- use of heating devices (with the exception, of course, of built-in heaters)
- use of cooking and food heating devices (kettle, sandwich oven, microwave oven, hotplate, etc.)

2.3. in the dormitory kitchens

- to prop the kitchen doors
- unsupervised use of ovens and hotplates

2.4. in the yard, in the garden, on the sports fields

- smoking - except for designated smoking areas
- bonfires - except for the designated bonfire places with the permission of the head of the dormitory or the supervisor on duty

III. SMOKING

Smoking, activities that cause fire and smoke are strictly prohibited in the dormitory buildings. Smoking is only possible in designated smoking areas in the courtyard of the dormitory.

Designated smoking areas:

1. the smoking area marked with a sign is located near the entrance of the building (facing the entrance only on the right side, not on the other side)
2. designated area in the courtyard of the dormitory (between the "A" building and the "Rádl árok" street fence)

IV. ACTIONS IN CASE OF A FIRE ALARM

1. Anyone who notices a fire or its immediate danger must notify the porter immediately, even if the fire alarm has not yet sounded.
2. In the event of a fire alarm, dormitories must leave the dormitories immediately via the designated escape route.
3. Gathering outside the building on Kunigunda road.
